The child's file must include the name, address, and home and work numbers of at least two people authorized by the child's parent to pick up the child within 1 hour if the parents cannot be reached.

	Comments: During the renewal inspection, the inspector observed that the daily attendance sheet did not identify whether the absence is due to illness. The operator must indicate the reason for the child's absence on the daily attendance sheet. The inspector also observed that the departure time of 2 out the 6 children was missing o Monday. The operator must indicate the time of departure of each child on the daily attendance sheet.							
General Comments								
	During the renewal inspection, the inspector observed snack time, indoor free play, outdoor free play, lunch and quiet time.							
	The inspector recommends not using the large play structure in the park since the protective surfacing and the ground is frozen. Due to the ground being snow covered the inspector could not observe if two types of surfaces are offered. The park assessment will be done in the spring with a member of the permit delivery team.
