The associated person has access to the children. The operator must ensure that the associated person in the home received is vulnerable sector check.

Comments: During the renewal inspection, the inspector observed that the daily attendance was left inside while the children were playing outside. When children are in the outdoor play area or on outings, operators have copies of the attendance records with them as well as emergency contact information. The operator must ensure that the daily attendance is brought outside.

Comments: During the renewal inspection, the inspector observed a container of Lysol wipes over the refrigerator. The operator immediately locked the container of Lysol wipes in a locked cabinet. Deficiency is now compliant
