Comments: During the renewal inspection, the inspector observed 5 children in the washroom being supervised by the Inclusion Support Worker. As per the Regulations, an Inclusion Support Worker providing services to children with additional support needs does not count towards the child-to-staff ratio. The inspector requested the administrator to have an educator supervise the children instead. While on site, an educator went in the washroom to ensure compliance with the child-to-staff ratio.Deficiency is now compliant.

Comments: During the follow-up inspection, the inspector observed that a first aid (FA) certificate and a cardiopulmonary resuscitation (CPR) certificate is not a level C certificate. The operator must ensure that a copy of a valid Workplace Standard First Aid and CPR Level C; certificate is obtained and maintained in the educator's file.

A check with the Department of Social Development is also required if they have contact with children or responsible for finances as part of their role. The administrator indicated that the Corporation Directors are not involved with the children, or on the site currently. Administrator must ensure that these checks are completed.

During the renewal inspection, the inspector observed the children dancing in the chapel, an educator enthusiastically reading a book, another educator sitting on the floor playing a memory game card with the childrens, nap time, and children playing freely both indoors and outdoors. One classroom is hosting a potluck with children and their parents in the afternoon.

General Comments

During quiet time, the inspector observed 5 children who are not sleeping in 1 room. Children resting on mats, but remaining awake, must not be required to stay on the mat for longer than 30 minutes as per the Operator's Manual. The inspector recommends providing toys/books to the child that is awake during naptime.

Regarding regulation 33(2), the inspector was unable to verify the type of surface due to the snow on	the
ground. This aspect will be checked at a later date.
