The educators were observed engaged in conversations with the children and taking the time to listen to them and to respect their ideas and conversations.

Interest centres are set up throughout the gymnasium for the children to have a variety of materials to interact and engage with.

Recommending that in the spring more mulch be added to the School-Age fenced in play area under the fall zones on the stationary equipment.
