<p>Comments: The twisty slide in the play structure is not safe for use as the bottom of the slide has a missing screw which connects two segments of the slide, causing the two pieces to separate and a small gap has developed. The plastic frame that covers the screws where each segment of the slide joins the next one are broken or missing. It is recommended that children are not permitted to use the slide until it has been repaired.</p> <p>There is a broken shelf that is not safe as there are screws sticking out. The shelf needs to be fixed or removed for the children's safety.</p> <p>The laminate of the table top is cracked and have developed jagged edges which children can cut their hands on. The table must be replaced or removed.</p>

<p>Comments: In one preschool room, the art materials were not easily accessible on low, open shelves. As they are up high, the educator stated that the children have to ask to access the materiel. Age appropriate materiel must be placed on low open shelves so the kids can have access to free choice activities.</p>			

<p>General Comments</p> <p>Ratios were satisfactory during the inspection.</p> <p>The educators had the children outside for a long period of time which gave the children outdoor opportunities for physical activity.</p> <p>The QA monitor noticed some duo tangs with prepared work sheets in one of the preschool classrooms. We discussed with the administrator that the preschool groups must use the curriculum and work sheets are not recommended. The educators can contact their curriculum consultant or their QA monitor for further support.</p>
