Each classroom could demonstrate that they have a pre-planned flexible program that is built on the children's interests. They are using pictures, children's artwork, learning stories to show what they are doing. The educators are adding props and materials into the environment to enhance the children's learning and interests.

Educators were observed engaging with children through conversation, playing and taking interest in what the children were doing. When difficulties happened within the environment, educators were seen redirecting or helping children problem solve before they intervened to find a solution.

The Operator has added more shade to the outdoor play area and planters. This is a wonderful addition. The outdoor play space has more added learning centres than previous inspections which has been a very positive change to this space.
