<p>General Comments</p> <p>Upon arriving, I was screened, my temperature was taken, and I was signed in. There is COVID signage at the entrance, and the postings required for licencing regulations were up. A couple of postings need to be updated to reflect some new information, as discussed.</p> <p>The educators displayed positive child guidance such as gentle reminders, encouragement, and they were engaged with the children. The only class that needed to be divided due to COVID guidelines was the 4's room. The classroom was divided well with clear boundaries, and the groups take turns using the playground. It appears that this is working well in the classroom. There are sufficient age-appropriate materials for each room and the cleaning routines are being followed.</p>

General Comments

I saw children's work in each of the classrooms, and I was also shown the app that they are using to share information and current updates of what activities the children are doing. The program appeared to be running smoothly on the day of my visit.
