Licensing staff also observed an ongoing mark making activity set up for the children in this classroom. The educators taped a large piece of paper to one of the tables in classroom for the children to doodle on throughout the day. The children are enjoying this activity.</p> <p>The Administrator sent along the registration date for the First Aid and Cardiopulmonary Resuscitation course to be completed on January 17th, 2025. A member of the management team will send along the updated First Aid &amp; Cardiopulmonary Resuscitation certificate when the staff member completes the course.</p>
