Attendance and head count charts are complete. The September fire drill has been completed and recorded.

The educator remained engaged with the children playing cars with them and coloring. She took interest in what the children were doing and asked them about their weekends and day at school. Gentle, kind reminders were given for children to remain seated when eating and to use an indoor voice when playing.

Time warnings were given for children to know when it would soon be time to clean up before outside time.
