This centre also records temperature of the children in the AM. Staff are documenting mid day temperatures for children and the staff are also checking and recording their temperatures in AM and mid-day. Cleaning schedules for Covid are being completed. I observed a staff cleaning and disinfecting high touch surfaces and this should be done atleast twice daily and logged. A daily log is kept for each self contained group and the household member list is available upon request for contact tracing purposes. Please ensure each group and educator remain the same throughout the day even at the beginning or end of the day and for outdoor play. Refer parents to the parent portal for updates to the Covid Recovery Phase document.

- *This facility has added a Management of Illness Plan to their parent handbook.
- *Please find suitable storage for the nap mats in the 3 year old room, as this is taking up space. If mats are stored touching they must be cleaned and sanitized prior to use.
- * Lovely new tables and chairs observed in some of the programming rooms.
- *I did observe outdoor play during my visit. Children also went down for nap during my visit.
