General Comments

Licensing staff was screened for Covid-19 upon arrival at the licensed facility.

The Director of the licensed facility and licensing staff went into one classroom to calculate the child-to-staff ratio, it was noted that a classroom was not operating within Regulation 9(1) of the Early Childhood Services Act. When this was brought to the attention of the Director, the Director stepped into the classroom so that child-to-staff ratio according to the Early Childhood Services Act would be maintained. At this time, licensing staff and the Director also discussed Section 8.1.4 (Supervision) of the Operator Manual where it states the

following:

"To ensure that children are properly appropriately supervised at all times, the child-to-staff ratio must be maintained:

- 1) during the operating hours of the facility;
- 2) during arrival/departure times and during staff lunch/breaks;
- 3) during outdoor play; and
- 4) at all times (even nap time) for children younger than 15 months of age.

During lunch breaks when children are napping, staff members included in the child-to-staff ratio must remain on-site and are easily accessible within the building.

The child-to-staff ratio for children in a group may be reduced by one-half for napping children (for example, one staff member to 10 two-year-olds), provided that one staff member is present in the same room as the children."

While licensing staff was inspecting the indoor play environment it was noted that two children were in a classroom unsupervised for a short amount of time before the educator and the remainder of the group joined them in the classroom. Please ensure children are supervised at all times in order to maintain the safety of the children.

While licensing staff was conducting observations in the indoor play environments, it was noted that the laundry detergent was not secured behind a door that was locked with a lock and key. Please ensure that all toxic materials (laundry detergent) are inaccessible to the children in order to maintain the children's safety.

Licensing staff was observing outdoors in the older children's outdoor play environment when she noted that the protective surfacing surrounding the stationary equipment did not measure 30 cm. Please ensure the depth of the protective surfacing surrounding both pieces of stationary equipment located in the older children's outdoor play environment measures a minimum of 30 cm.

During the licensing renewal inspection, it was noted that the educators in each classroom were engaged with the children at the child's level and were very nurturing and compassionate when a child was were upset.

Staff files were complete and organized.

The indoor play environments had multiple pieces of documentation posted on the walls to display learning experiences.
