Monitoring inspection performed.

Licensing staff observed many new staff since the last monitoring visit. Administrative records were reviewed - staff and child attendance, new staff info was reviewed, infant toddler records, potential illness forms, and incident reports. Please remind educators to complete potential illness and incident report forms in full - including the date, departure times on Potential illness forms, and that incident forms are signed by parents, so they are aware. Some of this information was missing on some of the clipboards. Please ensure they get filed

accordingly so they do not get misplaced.

All children were observed in outdoor play this AM and PM. Licensing staff expressed to the Administrator that on the larger structure a small child slipped and fell from the fire pole onto the hard snow. The Administrator decided to put up caution tape around this area of the outdoor play structure, alerted staff to supervise children to ensure they do not access with exception of the slide.

Children were observed indoors playing with magnetic blocks, lego blocks, wooden blocks, and creating valentine cards. The theme in all of the classrooms is Valentines. Current programming was posted also. All children were observed eating lunch (carrots, potatoes and fish cakes), and going down for a nap. Only 2 food groups provided during noon meal, therefore please review your menu options and ensure all groups are recognized at the noon meal.

Appropriate child guidance was observed, and staff were observed comforting a child who fell from the fire pole and showing recognition when a child was doing a good job. the Educator said 'good job, that's alright". Some staff must be mindful that children take alot of time to complete tasks. Patience and kindness can go along ways. Listen and take the child's lead and take time to assist children that you recognize need help with removing outdoor gear, boots, and when putting on indoor shoes. Make it a fun activity. Praise children when they accomplish the task. Licensing staff observed one group of children coming in from outside being hurried to get undressed and some children needed assistance.
