Comments:	This centre has 2 outdoor playspaces - one designated for infants and one for preschoolers. Licensing staff recalls a conversation with the Administrator about changes to the larger play space as it is not meeting section 31(4) (b). It must consist of more than one surface to permit different types of play. If the Tiki Hut does not get installed by the end of May, she will remove the pea gravel around the perimeter as there is pavement under the pea gravel. The infant area has 2 surfaces which is meeting this section of the regulation.

General Comments

Monitoring follow up report performed. Please review above comments for addressing compliances. Verification of staff information including Operator- Board members was reviewed during the inspection visit. Administrative records - attendance, infant toddler records were reviewed, and this info is being recorded as the day progresses. One observation - please ensure staff add signature to infant toddler records and medication records. Licensing staff observed first names only and this was discussed with the educators in the room that was identified.

transitions and use positive language when interacting with children - by using gentle reminders, offering help

with dressing and undressing and providing ample time for transitions and completion of activities.

Children's medication records are being tracked by staff. After discussion with the Administrator about reviewing section 10.4 pg 80-82 in the Operator manual, the administrator stated that parents are completing appropriate form for documentation of medication and health plans which is stored in the child file. However, educators while tracking administration of medication should have a copy of this health plan for ongoing medical conditions to reference. Licensing staff observed "period of time was also missing from the form in one of the classrooms, so the educator would not know how long to administer the medication as it was not indicated. Please ensure parents provide clear instructions, so staff know their responsibilities and how long to administer medication. Today, all children were observed in outdoor play. Outdoor toys and equipment need cleaned. Licensing staff observed new storage sheds located in the outdoor play area to house smaller toys, equipment and materials and makes it easily accessible to children. Leave the doors open to make it accessible to the children. A couple of groups returned just before lunch that had gone for a walk or to the park. One educator indicated the children love going for walks and enjoy scavenger hunts, playing with knecks, blocks and Art are also popular. Children were observed coming in from outside and washing hands. The policy at this facility is to use the one hand station in the entryway to wash children's hands before proceeding to their cubby. Licensing staff noticed the small entry way was very congested and crowded with 14 children and 2 staff trying to wash children's hands at one hand station. Licensing staff offered a suggestion to divide the group in 1/2 and coming inside with smaller groups at a time. Licensing staff observed children left standing idle and waiting to wash hands, then proceeding to their cubbies to remove their outdoor clothes, boots etc.

Indoors Educators set up stations in the classroom to support the children's interests. Currently children have been involved with Spring activities and the babies made a beautiful ladybug. Programming was posted in many of the classrooms, though one room seemed sparce and lacked sufficient toys and equipment.

Lunch served - Corn and Ham chowder with biscuits. Ample food was served, and some children asked for seconds. One would determine this meal was a hit with the children.

Some Educators were assisted with undressing children after petc. Remember it takes children along time to dress and undre independence, but all children need to be given appropriate time.	ss and it is important to encourage
