General Comments

Upon licensing staff arrival, it was noted that the entry way and hallways are very bright and inviting. Childrens artwork, photos are on the walls, and it was nice to see the staff profiles and pictures. The Director was very welcoming and engaged with the children when they arrived.

Licensing Staff observed the Critter Room having their morning snack and watching a bird at the window where a small bird feeder was placed outside. Educators were engaged with the children and said how great of an idea it would be to build their own little bird houses. The classroom was organized, tidy and bright. Materials such as costume play, blocks, a play kitchen and BBQ, Lego, wooden play pieces and seashells were at eye level and labeled in three languages. The daily routine, menu, learning stories and artwork were all posted and recent.

The children played throughout the morning, went on a walk and when they returned had lunch. After lunch, the classroom was cleaned, and the children went outside to play.

The Jungle Room was observed during snack time, indoor and outdoor play as well as lunch time and nap. It was noted that during snack time, an Educator was re-arranging the play space. The play space should be arranged and ready prior to daily activities. To ensure a positive snack experience for the children, Educators should be engaged and interact during this time. Toys and materials such as cars, blocks and art supplies were present. The books on the shelf are beginning to become ripped and worn. Please ensure a sufficient number of books are accessible.

The Canucks Room was observed while the children were getting ready to go for a walk to the Police Station. The play space had a sequins board, a sensory play table with shredded paper, small scoops, cups and plastic forks. Stations were set up and labeled for the kitchen area, artwork, dolls, trucks and blocks. The quiet corner is too small for the number of children that were wanting to listen to the story. Please ensure that there are adequate amounts of books and that they are in good repair.

When the Canuks returned from their walk, lunch time was observed. An Educator filled up the children's water bottles with fresh water and sat with them during lunch. An Educator asked the children about their walk to the Police Station and the new police dog. The children were happy and cheerful and then began to talk about their own pets.

The Shining Stars Room was observed getting ready to go for a walk. An Educator sat with a few children reading a book while the other prepared with sunscreen and changing. The room was inviting with family photos, hanging artwork, a play kitchen, books, blocks, wooden puzzles and dolls. Once they returned from their walk, lunch was observed. The children ate together at a small table and an Educator offered assistance and guidance when needed. Kind and caring words of encouragement were observed.

The Zoo Room was out for a walk upon licensing staff arrival. The room was tidy and organized. Family photos were on the wall and play material such as blocks, trucks, small comfy chairs and books were available. Please ensure books are in good condition and removed if damaged.

It is recommended to add additional shade in the preschool aged outdoor space.

Staff and child files are complete and organized.
