On the morning of the monitoring inspection, all children had outdoor time before lunch.

In the Critters Room, children were preparing to go outside for a walk. One educator remained in the doorway while children went to the washroom directly across the hall, while the other educator retrieved the outdoor clothing from the hall and placed it in individual piles in the room. The transition of getting dressed in coats, boots, mitts, and hats was smooth and educators provided assistance to children who needed help.

The infants from the Zoo room were outdoors and infants are adjusting to the colder weather. The educator sat with the infants and warmly greeted a family when they arrived to drop off their child.

The children from the Jungle room were also preparing to go outside. Educators spoke kindly and set out toys on the blue mat when children began to run around the room in their snowsuits. A suggestion would be to also play familiar songs for the children to sing along to during transitions.

General Comments

The Canucks room was on a walk during the morning and returned at lunch time. Lunch was baked fish, mashed potatoes and peas. The menu accurately reflected this meal as well as the morning snack. Educators used positive child guidance when speaking to the children about sitting safely on their chairs.

The Shining Stars room had outdoor time in the morning and were observed before lunch. Educators worked together to get diapers changed and infants in their highchairs with bibs for lunch.

The centre is being painted this weekend. All required documents were still posted but children's artwork and other decor has been removed. Please ensure that after painting has been completed that artwork, children's photos and other documentation is put back up.
