<p><b>General Comments</b></p> <p>Monitoring visit.</p> <p>Upon arrival one group of children had finished snack and were listening to a story, and another group was eating lunch and then cleaned up before listening to a story. Educator was observed assisting children with opening snacks and sits and eats with the children making this a wonderful social experience for all. Educators in both classes invited children to participate while they read the story. They asked questions to encourage children to participate and talk about the story. After story, one group was interested in playing with dinosaurs and building a landscape to play with them using playdoh.</p> <p>The forest school group are learning about the seasons. They were talking about the fall equinox and this season in particular. They discussed changes that happen in fall - leaves turning, how to dress etc. After story time, the forest school group got dressed for a morning excursion to search for signs of fall and build on their class web. Children and staff were dressed appropriately for the weather. A rainy day, so children dressed in splash pants, muddy buddies and jackets and boots. The centre also provides this gear in case children forget to bring. They took their lunch bags as they plan to eat lunch in the cabin.</p> <p>Lots of conversation, interaction between staff and children.</p> <p>Positive child guidance was observed. Licensing staff overheard educators saying "I'll help you with this, Lets get our splash pants on first". Educator used positive language when engaged with children "Good Job". Lots of wonderful positive interaction. Children were observed imitating their educator when they listened and sang songs together. Transition time was provided between activities and children were observed helping with clean up.</p> <p>Administrative records were reviewed - children's attendance is tracked and child signed out when leaving early with a parent.; new staff info was also reviewed.</p>
