The centre is nicely set up with many natural materials. The plants give the center a home like feeling.

The preschool children were outside when I arrived. The theme of the week was camping. The children were in the forested area having a small campfire and enjoying s'mores. During the campfire one educators stays next to the fire. The children have to keep a certain distance from the fire. After the campfire the children were able to explore the forest. Some were playing in the mud kitchen, while others were relaxing on the hammocks. Other children were running around through the trees.

The afterschool children were having snack inside when I arrived. Once snack was finished the children headed outside. The afterschool school children were observed laying in the hammocks, playing in the mud kitchen, riding the bikes on the trail and building towers with the blocks.

The educators were friendly and interactive with the children.

Licencing staff wanted to review staff files as two educators needed to be added into the system. The operator was not at the center during time of inspection and the educators did not have access to the files.
