Comments: Deficiency is now compliant. Licensing staff had access to educator files during the inspection today. Please ensure all files are accessible to authorized government representatives at all times when the Operator is not available. The Operator has made arrangements that staff have a key to the Operator's office.

Comments: Deficiency is now compliant. Licensing staff did observe cleaning bottles labelled with Mr. Clean and water. It was observed being used on tables where children eat. Mr. Clean is not a sanitizer but can be used as a cleaner for cleaning non-food contact (non-mouth toys) surfaces. It is a not food safe product. The Operator corrected this during my visit. She decided to commence using soap and water to clean eating surfaces then use Sani-Q to sanitize.

Comments: Deficiency is now compliant. Licensing staff observed the cupboard was unlocked but this was corrected during the inspection visit.			

<p>General Comments</p> <p>Quality Assurance Monitor Troy Williams completed an inspection in August. A follow up monitoring inspection was completed by Joanne Voyer Page.</p> <p>During today's visit, new staff files were reviewed and were assessable to licensing staff during today's visit. Administrative records were reviewed and attendance, fire drills, outdoor maintenance check list and incident reports are being tracked. When writing up observations on children, please ensure educators treat them the same as incident reports. Parents should be signing off so they are being made aware. Also please ask educators to add the time of day to their non reportable incidents. Licensing staff observed many did not include the time.</p> <p>Educators are on track to complete 10 hours of PL training. A new staff has been registered for the 90 hours and the staff that commenced work in August will only be required to complete a percentage of hours based on employment date.</p> <p>The centre is inviting, organized into programming stations that are easily accessible to children. Programming</p>

and planning is evident in all the classrooms. Educators use a journal for planning. Children's learning is posted and made to feel important. Some programming is framed, and some learning stories are attached neatly to construction paper and posted throughout all the classrooms, so children can refer and reminisce. Books about fall, Halloween, and school is current and reflects Autumn. Love the sign in system in the 4-year-old classroom. This helps children recognize their friends' names and builds on literacy skills as the educator has a created a picture tag for each child with their printed name. Educators also have created learning portfolios for the children which can be shared with the parents.

All children were observed finishing snack and getting ready for outdoor play activities. Children expressed excitement as they were off to the bike track. Educators were observed assisting children with dressing for outdoor play.

All children were observed in outdoor play. Children were observed playing in the mud kitchen, pretending to make ice cream and soup. Other children were making splashing sounds with their feet while running through the puddles. The operator is building a storage shed to house outdoor toys and equipment. Educators supervise appropriately and no children were observed playing in or around it.

A couple of observations - there is a picnic table that needs discarded or the wood needs replaced as it is rotting and jagged. Children were not playing on it during the inspection.

The younger preschool age children were observed going for a nap. Quiet soothing music was played. Well operated facility.
