General Comments
<p>Licensing staff arrived at the licensed facility to conduct the annual license renewal inspection while some children were still being dropped off for the day.</p> <p>Licensing staff observed the children engaging in invitations of play set up by the educators in the classroom. The four-year-old children were engaging in a number of activities. The children were free to move from one activity centre to another.</p> <p>The two-year-old classroom children were getting washed up for morning snack when licensing staff entered the classroom to conduct observations. After the children were done their snack, the educators washed them up again and began assisting the children put on their outdoor clothing for outdoor play. The transition from inside to outside was very smooth. Once 5 children were ready to go outside, one educator took these children out while the second educator assisted the last child to get dressed and then joined their classroom outdoors.</p> <p>The three-year-old classroom children and educators were already outdoors when licensing staff observed their play. The children and their educators were making snowballs and using the snow shovels in the freshly fallen snow.</p> <p>The educators in each classroom were very engaged with the children whether they were indoors or outdoors.</p> <p>Child-to-staff ratios were in compliance according to the Early Childhood Services Act.</p> <p>Please update the new inspectors name and contact information on the parent communication board.
