General Comments

Licensing staff arrived at the licensed facility as the children were still being dropped off for the day.

The children were indoors and engaging in free play activities when licensing staff arrived at the facility. In the three- and four-year-old classroom children were playing in multiple play centres set up for the children. Some children were making a pyramid using blue plastic drinking cups while other children were putting a puzzle together in the cozy corner. Another group of children were adding to a block creation that was created and saved from a previous day. The children building a pyramid were not finished building when the educator gave the children a five-minute prompt that it was time to clean up and get washed up for morning snack. At the end of the five minutes, the children chose to come back to this activity later in the day, so the educator asked the group of children to pick up the toys around the pyramid, and they could leave the pyramid where it was so they could revisit building it later.

In the three-year-old classroom, the children were observed listening to their educator read them a story called, "The Mitten" by Jan Brett. After the story, the children got washed up for morning snack before going outside to play.

The two-year-old children were finishing up their morning snack when licensing staff entered the classroom and then went outdoors to play. Licensing staff noted large animals on the wall that an educator drew, and the children painted, from the children's storybook, *Baby Bear, Baby Bear, What Do You See*, by Eric Carl. The educator in this classroom shared with licensing staff that the children go around the classroom room and retell the story in their own words using the animals posted on the walls.

All preschool classes went outdoors to play in the morning. Some children were observed shoveling the newly fallen snow off their "skating rink" using child sized plastic shovels. Other children were observed making snow angels in the snow and playing on the wooden tetter-totter. All children played outdoors until it was lunch time.

When the school-aged children arrived at the licensed facility in the afternoon, they played indoors for a bit before heading outdoors to play. While indoors, the children engaged in free play activities. Some children

played cards while other children engaged in dramatic play pretending to write their friends emails using a keyboard and a computer while another group of children built a fort using blankets, hollow wooden blocks and a couple of cardboard tubes.

All child and educator's files were complete with the required documentation and licensing staff noted an abundance of documentation posted on the walls for the children to revisit their learning experiences.

Licensing staff recommends the facility for their license renewal.
