## **General Comments**

Monitoring visit performed. This facility recently changed from a FT to a PT service commencing in September, however currently the centre is offering a temporary full time service with the strike that commenced today closing schools and moving learning online. Small group in attendance today.

Administrative records were reviewed - and the Educator is recording attendance, fire drills, outdoor check list etc. No incidents to report.

Lots of changes observed from my last visit in May due to the switch to school age only centre. Toys, equipment and materials are age appropriate, nicely organized, and easily accessible to the children. There is a games room, loose parts/craft area, for exploring different kinds of materials, block area, lego, white board, books and work desk area. Art work was observed posted. Very inviting. Lots of changes to outdoors as well. The operator has added a ninja course, balance beam- though used more with the building area. If used as a balance beam, the mulch will need to be loosened up regularly. The Boys are currently creating and constructing a fort with building materials that have been provided and they use the balance beam as part of the fort. There is a soccer net in place, quiet areas for reading etc. Though the Educator provided picnic mats for the children to sit on today, it would be recommended that children have access to a picnic table to sit when outdoors for online learning. The educator showed me on See/Saw all the activities the children have been involved in the past few days that school has been closed. It is obvious the educator takes this into consideration with the current strike situation, and additional programming is evident and incorporated into the children's routine. She also sets aside some quiet time for children to work on school activities. The educator is very engaged with the children and they seem very comfortable talking to her as well.

I mentioned to the Educator, to keep the toxic products cupboard in the bathroom locked at all times. Thank you.
