<p><b>General Comments</b></p> <p>Monitoring visit performed. Upon arrival the educator and children were observed in the outdoor play area. Wednesday's are a half day and children arrive off the school bus at 12:15 and go directly indoors, wash their hands and eat lunch. It is a beautiful warm sunny spring day and the children wanted to go outdoors, so the educator took the children's lead. Some children were observed playing a fun game of hockey ball, others were relaxing nestled into a tree, other children were sitting watching the game and another group were playing next to the storage building. The educator was aware of this group and appropriate supervision was observed. She was seen walking back and checking on the children. The educator's has a great rapport with this group. She was very engaged and interacted positively with them. The outdoor play space is inviting and lots of activities for the children to explore - I observed a new ninja course. painting easel and loose parts set aside as they really enjoy building with these materials. I also observed the operator has purchased additional mulch for the outdoor play area. I would recommend poking holes in the big tire to allow the water to drain. Not really an issue at this early time in the spring but it will be a draw for mosquitos and black flies later on. The ground is currently quite saturated and a bit muddy in areas. But the children don't seem to mind. The plan for the afternoon is to continue playing outdoors, though the Educator stated they sometimes leave the yard and go for a walk. Some children were observed leaving during my visit.</p>
