<p>General Comments</p> <p>Monitoring inspection performed.</p> <p>Administrative records were reviewed - attendance is tracked (no illnesses to report), incident reports are completed and signed off, so parents are aware; outdoor check list is completed monthly including first aid checklist. Fire drills are also being completed monthly and the fire extinguisher was recently serviced in April. It was determined during the visit; the operator needs to use the updated Fire Drill report - Appendix 16 in the Operator manual to track fire drills. This form also permits the educator to check smoke detectors monthly and to indicate when the fire extinguisher was serviced. Please print and attach to your existing record and commence using the updated form.</p> <p>Today during licensing staff visit, children were seated eating lunch and enjoying pleasant conversation. Children are very respectful of their friends, and everyone had opportunities to talk and ample time to finish lunch before moving onto to afternoon activities. Children are familiar with the routine and once finished eating they put lunch box away and have free choice of activities.</p> <p>Lots of options for children to choose from - a variety of loose parts, knects, lego, fidgets etc. Toys, equipment and materials are varied and in sufficient quantity and appropriate for the ages served. They allow children to experiment, explore, build, create and design things. All children were observed playing cooperatively. The educator follows children's lead and assists when they need help. Appropriate supervision was observed. Positive interaction and conversation were also observed between the educator and children. Children have also planted wildflowers for Mother's Day.</p> <p>Outdoors there are a variety of natural elements, loose parts (building materials) so children can create and build. There is also a small zipline. Mulch is also on order for this, and the Operator also places mulch in and around the treed area on the property. This age group enjoys outside time and children will be going outside. The educator does follow the children's lead in this case and today the educator gave children lots of uninterrupted time to play indoors. During previous visits licensing staff has observed children in outdoor play. It was nice to see everyone involved is a variety of fun, appropriate and educational activities during the visit.</p>
