The rooms were clean and organized and all play material was in good condition. Play material such as board games, a doll house with accessories, and loose play pieces, were set up in centres and was easily accessible for the children to use freely.

After snack, some of the children began to build a remote-control Mario racetrack. The Educator was observed providing assistance in snapping some of the pieces together on the table and the children were eager to race.

Positive child guidance was observed, and the Educator was actively engaged with the children. Child and staff files were in order and all required documentation was visibly posted on the parent board.

Later in the afternoon, the children were given a gentle tidy up announcement and cleaned up their toys before going outdoors to play. The outdoor play space is gated with large trees for natural shade. There were ball hockey sticks and a net, a mud kitchen, stepping stumps, soccer balls and a soccer net, and a hanging obstacle course. Children were observed playing with a large checkers board, colouring and playing soccer. While playing soccer a child had a little fall. The Educator gave hugs and ensured the child was ok.

The children's belongings were organized in a separate room with labelled hooks. Children's artwork was displayed throughout the centre. In the main room there was a Birthday celebration wall and an Outdoor Adventure wall with photos and write ups on activities. During my inspection, the Fire Marshal arrived to conduct the yearly Fire Inspection. He greeted the children and they were happy to see him.
