General Comments

Only one child was in attendance at the beginning of the afternoon. Two educators were on site. One played Skip-Bo with the child and I heard lots of praise and conversation. The educator was showing them how to shuffle the cards.

Licensing staff observed the other educator in the kitchen area. They prepared a bleach/water mixture for cleaning and used test strips to check levels. They disinfected some high touch areas in the kitchen (doorknobs and shelf on door.) The kitchen was locked at all times.

When the other school-age children arrived, everyone washed their hands. Snack was served and children were offered oranges, granola bars, peppers, cucumbers, carrots and water. Educators encouraged children to try the veggies or orange if they initially said no.

Child guidance was positive, and two educators remained on site for the small group size. The additional educator allowed for extra support for children who needed assistance or reminders. During snack, children had time to share about their school day. When one child took an item from another child, the educators asked how the children could work through the issue. In addition, when one child was attempting to get the attention of an educator and was yelling, "Hey!", the educator responded calmly with "Hi!"

After snack, children were given a puzzle piece to design. It is a group project that will eventually be displayed to symbolize the unity of the group.

Child files were checked, and all required documentation and information is present. Incident forms are being completed and signed by parents. Potential illness forms and administration of acetaminophen records are evident in files and correctly being used.

There has been a bookshelf and sensory table added to the craft room. The large blue cupboard holds a number of craft items that are organized in clear bins with labels.

The centre was clean and organized. Children's artwork is posted. Other Boys and Girls Club documentation is
