Comments: While licensing staff was observing the children play in the back room of the facility, licensing staff noted the following: -a large hole in the wall and a pipe was exposed inside the wall; -a small hole in the floor at the back of the room, on the left side near the wall; -peeling paint on the walls. Please repair the hole in the wall and the floor. Please repair the walls that have paint peeling off.

Comments: While observing the children in the classroom where the children eat their snack, and while playing in the back room, licensing staff noted that some materials were provided to the children to play with but not a sufficient variety of resources were accessible to the children. Please ensure resources are added and accessible to the children to avoid the children from becoming bored and resulting in challenging behaviours.			

General Comments
<p>Licensing staff arrived at the facility while the children were still arriving for the day. The educators and children were outside playing.</p> <p>The children in group one engaged in free play activities outdoors before coming inside to wash up before have morning snack. After morning snack, the children played with Lego and dramatic play. Group one children transitioned from the snack room to the back classroom to engage in an organized game of "Hot Seat." Some children played the organized game while other children continued to play with Lego before transitioning outdoors to play until lunch time.</p> <p>Licensing staff observed the educators guiding the children positively using redirection and prompting the children that a transition will be happening soon.</p>

General Comments

The children and educators threw a football back and forth and played basketball with the children while outdoors before coming inside for lunch.
