General Comments					
The four-year-olds and school age children headed outside this morning to play after sunscreen. The educator putting sunscreen on the children was observed washing their hands between children. To provide an easier transition, one educator called up the children in one 4-year-old group to get ready to go out while another educator sat and sang and did fingerplays with the second 4-year-old group and after schoolers. The educators were engaged with the children outdoors playing ball and getting down to look at bugs and have discussions with children. The children were excited to see some wildflowers they planted in the garden boxes growing. Please ensure the playground is checked daily for any broken toys and/or containers. Each room went outside this morning. The 3-year-old group went out just before lunch and were having a picnic. The educators prepared any lunches that needed to be heated before heading out. Throughout the centre, documentation is posted on the walls. In the 2-year-old room, there was child-created artwork posted down at the children's level on each wall. Children's photos can be seen in each room and included on baskets at the cubbies for easy identification. The educators were observed responding to children's needs by allowing a child that was late to have a snack before heading outside and cuddling a child that appeared tired today. The centre was very clean and resources reflecting curriculum areas are provided in each room. The space is very bright and welcoming. There is a television in the main space downstairs that is occasionally used for the older children. There is a second television in the 3-year-old room that could be removed, if not used to provide more space. Please ensure the diaper changing procedures are posted in the upstairs washroom if children are being changed. Do not store lunch boxes or materials on the stairs as it is considered a tripping hazard. Reminder that educators under the age of 19 are not to be responsible for a group of children by themselves.
