General Comments

Monitoring inspection.

Upon arrival all children including infant and toddlers were in the outdoor play area. All children and staff were dressed appropriately for the shower/rainy weather today. One big downpour while outdoors and most all staff and children took cover under the big trees or small house area. The toddlers and babies moved indoors. Some children loved running around in the rain. Lots of activities in the outdoor play area, mud kitchens, kitchen centres including loose parts - wood blocks and logs that have been cut up and sitting in a pile that could be used for building. I believe, based on programming stories it has been used as a pretend campfire setting. Today I noticed children climbing and walking on top of the wood which is unsafe. Please supervise children and remind them it is for using their imagination and to build things with. Lots of storage bins in the preschool play area but I would recommend another one in the baby/toddler outdoor play area to provide some protection from the elements.

Administrative records were reviewed- new staff records are in order, child and staff attendance is tracked, including infant toddler records and fire drills completed monthly.

Administration of medication was observed during my visit. - ie Appendix 7 was completed. however after administration of acetaminophen is given, the parent must be asked to sign a written acknowledgement that acetaminophen was administered with consent. Refer to appendix 8 and have parents and staff complete and sign the form each time this is administered for teething purposes. This was my understanding why the child was given this today during my visit.

Lovely current document ation of children's learning experiences observed throughout centre. Children have been exploring and discovering sounds, taste testing, involved with sensory activities (babies loving the crushed cheerios pretending it as a sand experience, though I think they preferred eating it. One group was enjoying a memory matching game. The educator was very patient teaching children to take turns also.

All children were observed eating lunch and going down for a nap. Small school age group in attendance today. Lovely library centre set up in the school age room. Children also interested in lego and kitchen area and trucks/cars, loose parts and creative arts also available.
