<p>General Comments</p> <p>The children were playing outside in the outdoor play space when licensing staff arrived at the centre. Each classroom bubble had their own sectioned off portion of the playground. All groups went in to get washed up and have snack.</p> <p>Licensing staff began her observations in the 2 year old classroom. The indoor environment in the 2 year old room was very inviting as there were invitations of play set up for when the children finished their snack.</p> <p>After snack the children gathered in the book/reading centre for circle time. One of the educators began to sing a "good morning song" and the children joined in. After singing a song the educator read the children the story book "Fire Engine." Some of the children were interested in the book and some children were interested in playing with the invitations of play. The globe was especially popular with the 2's. All children engaged in the loose parts invitation of play. The loose parts invitation consisted of different sizes` and colours of pom poms as well as piece of cardboard in the shape of a cone. The children pretended to make ice-cream cones.</p> <p>After free play the 2 year old children went back outside to play.</p> <p>The educators in the two year old classroom were very engaged and interacted with the children at their level! Well done!</p> <p>The 3/4 year old classroom children were engaged in multiple learning centres while licensing staff observed in this classroom. One of the invitations of play consisted of a race track centre that had cars, dump trucks and trailers. One of the children took a small stump and set it on the trailer and drove the trailer across the classroom. The children enjoyed this activity. Other children in this classroom were engaged in a mark making activity which consisted of a white board and markers.</p>

General Comments

Licensing staff observed multiple learning stories posted on the wall along with other evidence of learning.

The educators in the 3/4 classroom were also very engaged with the children asking open-ended questions to extend the learning of the children.

The 4/5 year old classroom children were engaging in multiple learning centres as well during the time of inspection. There was a moon sand activity which consisted of moon sand, shovels, scoops and cups. When asked, a child told licensing staff that she was making, "a moon sand castle." Another centre that the children were engaged in was a painting activity and the third centre that the children were engaged in was a loose parts activity consisting of different colour rocks, wood pellets and some plastic greenery.

The educator was very engaging and interactive with the children in this classroom as well.

The staff and children files are very well organized.

Please ensure that the protective surfacing underneath the dome meets Regulation 33(2) of the Early Childhood Services Act which states that stationary equipment in the outdoor play area shall be surrounded by a protective surfacing and installed according to the manufacturer's instructions.
