One group were singing songs while waiting for their food to be prepared. All children bring snacks and lunch from home and educators heat up, and serve them to the children. Educators were observed assisting children when required - opening packages for lunch, helping with dressing for outdoors. Lots of wonderful gentle reminders to keep children focused. Appropriate child guidance was observed.</p> <p>Administrative records were reviewed during my visit, which included attendance of staff and children, fire drills, outdoor maintenance checklist, cleaning schedules etc. Please ensure attendance is taken for arrivals. This was corrected during my visit. Also, I observed a potential illness form that had been completed and signed off by the parent from February. Please ensure this form is filed in the child file. Thank you.</p> <p>New staff records were also reviewed.</p> <p>Lots of wonderful programming posted throughout the facility. Some children were enjoying topics on Mini mouse and construction books, other children were interested in learning about the Planets and many activities around this topic has continued. Great to see that learning continues to be extended. Now children are learning about land rovers used to collect rocks etc. Another group of children are into creating and building with lego. All children were observed getting ready to have a quiet time and looking at books or the younger children were going down for a nap. A special BD celebration today in one of the classes. Children were enjoying a McDonalds meal and cupcakes for dessert.. St Paddy's day celebration activities were documented from yesterday also.</p> <p>All children had outdoor play opportunities in the AM and the older preschoolers were observed in outdoor play.</p>
