General Comments

Licensing staff arrived in the morning to conduct a monitoring visit. Upon arrival the children were playing outside. The outdoor play area is quite large and inviting with hanging pots of flowers, sunflowers, a vegetable garden, large rocks to sit on, planters with marigold and geraniums and a really large cedar tree in the back section with a wooden platform around it that can be climbed on or used as a stage etc. The outdoor play area is fenced, and half has wood chip surfacing, and the other half has pea gravel and a concrete block path to ride tricycles on. They have some traffic signs saying stop and go to help make this play more interesting. In the middle of this pathway is a covered wooden archway to ride their vehicles under. The educators related how this archway got turned into a car wash which is a great example of how the environment sparks imaginative play and become the third teacher. There is a large playhouse with doors that open wide into it, window boxes with flowers in them, books, a table and a couch inside, which are also very inviting and welcoming and at night the tricycles and other ride on toys can be stored there. They have wooden storage boxes with pictures on them indicating what they contain, such as balls or sticks etc., wooden planters with loose parts like wooden block and sticks, child sized benches for sitting, and two large picnic tables. The educators brought out paint, brushes and paper and some of the children used the tables for painting. Larger paper was attached to the fence and could be painted as well. The children spent a lot of time outdoors, but the environment is so varied and has so many different invitations for play they did not run out of play ideas not become bored.

The inside play area is bright and clean and thoughtfully set up for the children's play. The entryway has a spacious cubby area with postings for the parents with information and learning stories such as "the Bees Visit" show casing the children's activities. The classrooms have child sized furniture, tables and chairs, cozy areas, real plants and an abundance of materials and resources for a variety of play.

The diapering area has a rail on the change table, and the diapering information is posted. The office is located near the back door, and the children can exit directly to the fenced in outdoor play area. The two-year-old room has a little stairway that allows them access to the windows so they can watch for their parent's arrivals.

The educators were very engaged and interested in the children's play and stories. They looked for ways to build on the children's interests, and the atmosphere was respectful and friendly. All child guidance was positive

and pro-active, and the daily routine was calm and unhurried. The administrator is on site and actively involved in the program and all the administrative requirements were met. The parent board was up to date and contained all the necessary postings.
