General Comments

Upon arrival, children were engaged in many activities throughout the facility. Educators were offering choices and interacting with the children at their level. Feet were being painted for a Christmas craft. Educators often could be seen redirecting negative energy and setting limits that helped promote more desirable outcomes.

Children went to Library, practiced for their Christmas concert and also went outside to play at time of visit.

Most of the outdoor play space is enclosed by the building. However, there is an opening at one end of the play space. Fencing would ensure the safety and security of the children. An exemption will be required until appropriate fencing can be put into place or a permanent request for exemption is approved.

Outdoor play space is currently snow covered and the depth of surfacing around stationary equipment and possible hazards could not be determined. An outdoor inspection will have to be conducted in Spring. However, please be advised that various types of surfaces that promote natural outdoor play experiences including trees, flowers, gardens, etc..to encourage children to explore their environment should be in place.

There was no evidence that potential illness forms are being used. Administrator stated that they have not had to use them.

Fire Drills are being done for each group in attendance at facility.

General Comments
A change in service form will have to be filled out by Operator to note the change in hours of facility.

There are two binders being used for reportable and non-reportable incidents. Administrator stated that there are not many incidents to report but knows the difference between the reportable and non-reportable. The last reportable incident according to the facility's records was on September 1, 2015. There were no non reportable incidents recorded.

Please ensure that current monitoring and inspection visits are posted after each visit. It is to my understanding that the reports go directly to the Board of Directors.
