General Comments

I signed in to the visitor log located at the door to the room. The program is using group logs to record the groups of children present. I also saw proper hand washing being done, and they are following current COVID guidelines well. Attendance records are kept up to date. The indoor area and the materials in the room appear to be well maintained and extra cleaning is being done regularly.

I observed the children partake in free play for a while before having circle time. The children have a good variety of toys and materials to play with throughout the space ,and they are kept low and accessible for the children. The educators were attentive to the children during this time. I saw many positive child guidance techniques used by the educators such as time reminders, gentle reminders, positive reinforcement, active listening, modeling, and taking the time to explain to the children as to why educators are setting certain boundaries on behaviors.

During circle time, the children were very much engaged in the activities. They went over some numbers, letters, and days of the week. Then they sang interactive songs with the children. The children and educators enacted movements associated with the songs. Today is the National Day for Truth and Reconciliation and during circle time the educators touched on 'every child matters' with the children in an age appropriate manner and they read an Indigenous book together. They then went outside to play before pick up time.

I looked at the child and staff files. The staff files contain all necessary documentation and the checks are all up Page 1 of 2

to date. The child files include almost all necessary documentation. There were a few immunization records, or exemptions, missing from the child files that will need to be obtained as soon as possible.

Overall, the program appears to be running very well and the children appear to enjoy the activities in the program.
