General Comments

Comments:

Upon arrival of licensing staff, the children had returned from school and were engaged in free play. Some children were having snack, and others were going art, playing with cars and playing with Legos. The educator gave a 15-minute prompt that it will be clean up time soon to get ready to go outside. The educators were engaging in conversation and playing with the children. The children then started cleaning up. The educators encouraged the children to go to the washroom before going outside. The children put their jackets and shoes on and gathered their bags. The children and educators walked out to the school playground together.

While outside, some children played on the swings and others were playing in the "gaga pit". The educators were spread out across the playground and engaging in conversation with the children. One educator was observed playing in the play structure and going down the slide with the children. Some children started running around the soccer field, playing a game of hide and seek, and jumping off the bleachers. The educators were ensuring safety and making sure only one child jumped at a time. The children and educators then transitioned inside to play in the gym for the remainder of the afternoon. The children took mats out and were building forts. Others played with ride on cars and basketballs. The educators were observed greeting the parents as they arrived and updating the attendance sheet.

The indoor environment had various materials available, such as art supplies, Legos, books, dolls, costumes, blocks, cars and tracks, animals, and a kitchen. The children use the school playground which was well-maintained. Staff files were checked and found to be complete. Only positive child guidance was observed. Licensing staff was informed that the renewal application is awaiting a few documents. Please submit renewal application as soon as possible.
