General Comments

Licensing Staff arrived at the facility to perform a Monitoring Inspection. Upon arrival, the 2-year-old class and 3-year-old class were outside in the fenced in play area. The 4-year-old class had gone for a walk to deliver Christmas decorations that the children had made. Once they returned to the facility, they joined the other classes in the outdoor place space. While outside Educators were spread out to ensure supervision was maintained at all times and were observed assisting children with their hats and mittens. Water bottles, first aid kits and attendance records were brought outside.

The classes transitioned inside one at a time, making the process smooth. Once back inside, the 4-year-old class was observed having circle time. The children watched a quick video "Mindful morning activity" where the children practiced deep breathing and positive affirmations such as "I am strong", "I love myself" and "Today is going to be a great day'. Afterwards the children were seen passing around a talking stick and telling the class how they were feeling today. The children were observed washing hands before having lunch.

In all classrooms, Educators were heard encouraging the children to try new foods. The Educators sat with the children during lunch and were engaged in conversations. In the 3's classroom a child was observed helping an Educator clean up dishes. The Educator was heard offering praise, "Yay! Great job! What a good helper you are!". Cots were set out while the children ate lunch. As the children finished eating lunch, they found their cot and prepared for quiet time. Blinds were closed, lights turned off and calming music was put on. All children were observed laying on their cots.

Only positive child guidance was observed during today's visit. Educators were attentive to the needs of the children. Age-appropriate independence was encouraged. In the 4-year-old classroom, children were observed using a variety of utensils to choose their lunch items from the provided menu. The classrooms are clean and organized. Webbing, learning stories and pre planned activities were observed.
