General Comments

Covid-19 screening was thoroughly conducted when licensing staff arrived to conduct the annual licensing renewal inspection.

It was observed by licensing staff that the all educators were very engaged with the children. The educators get down on the child's level when interacting and redirecting the children. Licensing staff observed the educators working on a craft with the children where children are learning their shapes, numbers and colours. Licensing

staff also observed educators reading to the children.

Cleaning supplies (toxics) were observed to be locked in the kitchen behind a locked half door however, a locked half door is not sufficient to maintain the safety of the children. When licensing staff discussed this with the Director of the centre the Director immediately told licensing staff that a heavy duty chain and a lock will be put on the cabinet where the cleaning supplies (toxic products) are stored.

Licensing staff observed that the curriculum being implemented at the centre is not solely based on the child's interests and is not as child led as it states in the New Brunswick curriculum. It was also observed that purposely planned activities are not posted on the wall or the communication boards within the centre. When speaking with the educators they do have a plan for activities in mind however, not posted. When licensing staff relayed this to the Director of the centre she immediately printed off documentation that will assist the educators in posting a week's worth of purposely planned activities in the future.

Upon review of the communication board located just inside the entrance of the centre a list of contacts for the Department of Education and Early Childhood staff is posted however, the contacts will need to be updated.

The educators, director and the children were very welcoming when the licensing staff arrived at the centre to conduct the licensing renewal inspection.
