General Comments

Upon arrival, the older preschool age children were having a quiet time and enjoying a free choice of activities. Later licensing staff observed the educator reading a story to these children, interacting with them, asking questions about the story. The younger children were napping - toddlers, as well as 2 and 3 year olds. Once they woke, Licensing staff observed children in the toddler room playing ball (throwing it to each other and trying to catch it). The educator praised them by saying - good job, good catch. The children were also observed playing with the dinosaurs. The 2's were playing with the magnetic letters. They are beginning to recognize the first initial in their name. They showed me the spider picture they decorated, and the children were able to identify the beginning letter of their name. Other children were playing with blocks and another child was practicing mark making on paper using markers. The 3 and 4's class - a couple of children were involved in dramatic play activity, another child was playing with her dolly and other children were looking at story books and coloring. The school age group had arrived and a group of them were involved with decorating their space for halloween. They worked cooperatively and helped each other. A few other children were into building with lego.

Administrative records were reviewed - attendance of both staff and children are completed, fire drill performed in October, but these are not always being practiced and documented. I also indicated above the outdoor maintenance checklist must be completed monthly.

During a walk around the outdoor play area the following compliances need to be added to the maintenance checklist and completed - move the small play climber structure to the protective surfacing area, repair fencing next to the garage, and store BBQ out of children's outdoor playspace, and gas can.

All children woke from nap and were observed involved in a variety of age-appropriate activities.

Children were observed eating snack. Licensing staff observed educators assisting children when a child asked for help. Children will be going outside after snack. The educator mentioned this to the children they would be going outdoors.

The educators are planning some activities and providing treats on halloween and children will be dressing up. Licensing staff observed alot of art work posted in programming rooms and the focus was halloween - spiders and witches.
