## **General Comments**

Upon arrival, school children were finishing lunch and other children had moved into quiet after lunch afternoon activities. They made slime this morning and some children were playing with this; another group was building with Lego and another group were enjoying tabletop activities. Everyone was playing cooperatively. The educator in this room left at 1 and another staff arrived to cover for the PM. All school age children were observed in outdoor play.

The preschool age group were finishing lunch and then children were observed being assisted by educators with toileting and washing hands. 14 children nap and so they moved to their respectful nap rooms. Two 5-year-olds joined the school age group while preschool children were napping.

Administrative records were reviewed - new staff information was documented; attendance is tracked for staff and children. Medication records are also being documented when routine medication is being administered. Just a reminder to staff to track cleaning bathroom checklist daily. It was last recorded on Tuesday this week. All room are nicely organized and inviting, and staff assist children and supervise bathroom breaks. All children were observed getting up from nap also during my visit.
