## **General Comments**

This is a follow up monitoring visit performed.

Upon arrival all children were in the outdoor play area. A beautiful morning to be outside. Children were sliding and climbing, driving ride on cars, playing in small groups. Educators were engaged with children and supervising children while outdoors.

Please see comments above regarding outdoor play area. I also recommended the small climber be moved to the protective surfacing area.

Children were observed coming indoors, supervised while toileting and washing hands before sitting down to eat lunch. Educators were observed assisting children with putting on indoor shoes, opening lunch boxes and food packages from home, speaking to them kindly. Licensing staff heard staff say "no thank you please, use our indoor voices, do you need help, do you need privacy.

Most children nap and were observed going down for a nap. Soft music was turned on. The older preschoolers played quiet activities. They also picked fresh vegetables from the garden. Children were excited to show me their finds.

Licensing staff observed new tables and chairs for all the classrooms. A nice find indeed.
