Comments: As follow up to last inspection visit, the Operator has hired a contractor to remove the gravel that currently surrounds the large play structure as per public health direction. Licensing staff's last visit observed that the surrounding protective surface was hard packed and needed to be loosened and that staff must ensure children do not play on the structure. The Operator has ordered appropriate pea size gravel, and the plan is to install this fall before freeze up. The operator was unable to find the manufacturer instructions, so they will be following CSA guidelines in the Operator manual. a new compliance date has been given. Please advise licensing staff when the work has been completed.

General Comments

Follow up monitoring inspection performed. Large group of preschoolers today.

Licensing staff observed lots of positive changes to the indoor play space. The Operator has updated two of the bathrooms on the main floor, - new flooring, new paint, new cupboard, new sink. Please ensure that educators label the diaper shelf with children's names. The kitchen also has new sink, taps and dishwasher. Licensing staff observed a Medication record on a clipboard, and this was complete with instructions and dosage. This form was being recorded when medication was administered.

All children were observed washing hands before sitting down to eat lunch. Children were observed eating lunch and educators were observed heating up lunches and/or assisting children with opening lunch containers or food packages. Please ensure educators when setting up nap room, that the cots are placed a minimum of 18 -24 inches apart. Ten nappers today. The older preschoolers were observed in quiet play activities.

Licensing staff noticed that many children had created handprint poppies, and these were displayed in the classrooms. Some educators keep child portfolios in their room.

Positive child guidance was observed, and licensing staff heard educators respond to children in a positive manner and also engaged in conversation. Educators would say - Use your words please, maybe not so hard, try to be gentle, good job. They encouraged children to select a book to look at while waiting for some of their friends to finish eating lunch.

Children were observed waking from their nap and some children were observed being picked up. The parent came indoors to get their children.

School age children arrived during the inspection and were observed playing cooperatively.

Discussion took place with the Administrator regarding illness and the licensing inspector provided an updated copy of the Guidelines for managing illness dated March 2023 and also a PH document regarding diarrhea and vomiting.
