General Comments

I signed into the visitor log upon my arrival. Some of the children were coming in from outside, and then after a little while, all of the classrooms had lunch. I observed proper handwashing being done at appropriate times during my visit. After lunch, some classrooms got ready for nap while children who do not nap did quiet activities. I noticed that the nap equipment in each room is well spaced out, and set up well. The infant nap room now has cribs rather than playpens, and I observed educators checking on the napping infants, following regulation.

The educators are keeping track of their continuing education hours. Some of the educators have completed their required hours, and others still need to work on obtaining more. Cleaning lists are up to date for the most part, with the exception of the washrooms. Please remember to keep these up to date as well. Attendance records and infant daily information sheets are being kept up to date. I also observed incident logs being completed and signed by parents.

There are learning stories on the walls in some rooms and they are well done. Some tie the children's learning back to the curriculum and demonstrate learning through play. There were some current ones up, but also ones that were outdated. Some did not have dates on them, and I suggest putting dates on each story and putting up newer ones every so often. I also suggest displaying them lower so the children can see their pictures and their activities. Children's work is displayed in most of the classrooms, and I suggest that they be displayed in every classroom. Please continue to build upon your program planning and documentation using the curriculum framework.

I looked at the indoor space and the materials available for the children. The indoor spaces appear to be clean. Now that we have returned to a normal cleaning schedule again, more materials can be added to the rooms. Some rooms can use more materials, while others have various materials that could be placed to be more accessible to the children. I will email specific suggestions to the administrator.

I saw positive child guidance during my visit and the educators displayed respectful communication, patience, gentle reminders, and redirection. The program seemed to go well overall.
