Arrived to perform monitoring inspection.

Observed one infant awake in the infant room while the other 4 children napped. Infant information forms were completed and up to date. Educator performed nap check during inspection and documented it.

Observed children in the four-year-old room transition from free play to lunch time. Children were directed to clean up by the educators and the educators played a cleanup song as a prompt. Children appeared to enjoy folding the blankets and face cloths they had been playing with when using the babies from the dramatic play area. Educators counted the children prior to walking to the bathroom as a group. The bathroom routine was efficient, and the children appeared to have a strong routine.

Observed children eating in the two-year-old room and transitioning to quiet time. One child was placed in a highchair to eat their lunch and educators explained that this child liked to wonder during mealtimes and would take food from other children. Positive behaviour guidance should be utilized to transition this child from the highchair to eating at the table with their peers. Proper meal etiquette can be modeled by the educators to help reach this developmental milestone. Quiet time transition took a long time as educators cleaned the tables and floors before settling the children into their quiet time routine. As a result, children began playing, jumping and hiding from educators in the room. Educators can settle children before they beginning cleaning the tables and

Children over 15 months old are to be given a mat or cot for quiet time unless written permission is given from a parent or medical professional to utilize a playpen for developmental reasons.
