Comments: On the day of the monitoring inspection visit, licensing staff noted that an infant transitioned into the two year old classroom a month before the child turned two years old. Please ensure that infants are not transitioned into the two year group until they turn two years old as per Regulation 10(7) of the Early Childhood Services Act.			

<p><b>General Comments</b></p> <p>On the day of the monitoring inspection visit, licensing staff arrived at the licensed facility as children were still arriving for the day.</p> <p>Once a majority of the children arrived at the centre, the children had their morning snack and then went outside to play on one of the two outdoor play spaces. The children alternate playing on the two outdoor play environments. Both outdoor play environments had a good variety of play materials for the children to engage with. Licensing staff observed all preschool children while playing outside.</p> <p>The snack for this morning was cereal bars and milk.</p> <p>All educators were engaged with the children and used positive guidance techniques when needed.</p> <p>There were no school-aged present at the time of the monitoring inspection visit.</p> <p>Please ensure that all children are signed in and out once the children arrive and depart.</p>
