Follow-up inspection visit to facility today, quality assurance mentor Mona Martin was with me. Ratio was respected during the visit.

One staff member completed their CRP course but did not have proof on site, the other staff member has not yet completed the course. The director must send proof of course completion as soon as possible as well as new date for the other staff member.

There were medications in the medicine cabinet without children's names on the bag/bottle. The director must

go through the medication to ensure all names are on the original container as soon as possible.

Recommending that an exemption request be made for a child that needs their medication on hand at all times, this will be sent to the operator. This particular medication must be kept out of reach of the children at all times.

Recommended that the triangular structure outside no long be used a climbing structure due to not having enough protective surfacing. The director plan to cover the structure with a tarp a use it as a tent area for the children.
