| Visit completed at the facility in the afternoon for a monitoring inspection. During the visit, the ratio was respected. Positive child guidance was witnessed during the visit. A daily incident log is maintained. Parent is advised of incidents and signs the daily log. The facility has the proper number of functioning and available toilets and sinks. Children are always supervised when using the washroom. A training seat is provided. Platforms are provided to allow children to reach toilets or sinks. The minimum space between rest equipment is at least 46 centimeters. All nap equipment is washable and non-absorbent. Nap mats are 5 cm in thickness and are stored so there is no contact with another nap mat. Each child has its own individual space to put their belongings. The space is easily accessible, labelled with the child's name and only used for the intended child. Outdoor play area is maintained safe and free of hazards. 1 educator is missing her CPR certificate. She must be with an educator who holds a valid CPR certificate. She may not open, close or be left alone with a group of children. Observation: 2-5-year-olds: I arrived during naptime. The 3 children that do not nap where playing table games with the educator. The children were drawing on drawing boards and creating art. After naptime the children had snack. After schooler's arrived from school and had their snack.
