Recommended all staff review the new COVID-19 guidelines.</p> <p>Educator was asked to place cleaning products under lock and key during visit, this was done immediately. Although the cleaning products were out of reach, they must be under lock and key at all times.</p> <p>Observations:</p> <ul style="list-style-type: none"> <li>- 2 year old group was having snack when I arrived, they then played outside with water guns, came in, had lunch and got ready for nap time. This group is presently interested in the sky.</li> <li>- 3 year old group was outside when I visited their room, they were also playing outside with water guns. They are presently interested in insects, ants and robots.</li> <li>- The four year old group went out for a walk during my visit. When they arrived they were getting ready for lunch. They are presently interested in trees and construction.</li> </ul>
