Strategies were discussed on how to apply each item within their group. Observation and reflection were done to evaluate with staff if all the items of the regulation are being applied into their classroom.</li> <li>-Daily routine into the center includes; Outdoor play time at least once every 4 hour blocks time when the weather is permitting.
