<p>Visit to facility for the annual inspection. Ratio was respected during visit.</p> <p>Recommended to operator that the diaper changing table be cleaned downstairs.</p> <p>Discussed with the operator the infant outdoor play area and recommended natural elements be added. such as plants, grass, pieces of wood, rocks or sand.</p> <p>Also discussed with the operator the corner of the fence near the "lookout", the sand must be racked away from the fence in order to ensure proper fence height of 1.22m in that area. Sand must also be racked under the "lookout" area regularly to ensure it meets proper depth of protective surfacing.</p> <p>There was a string on a pacifier in the infant room, this was removed during my visit.</p> <p>Observations:</p> <ul style="list-style-type: none"> <li>-Infants were inside playing in their classroom upon arrival, they had lunch then nap time.</li> <li>-2 year olds were outside upon arrival, they played with a bubble machine and other played in the sand. They came in, had lunch and nap time.</li> <li>-The 4/5 year old group were playing minute to win it activities, they had lunch then went outside.</li> <li>-2/3's were coloring and also playing minute to win it activities, lunch and nap.</li> </ul>

General Comments

-3/4's were also playing minute to win it games.

Facility is awaiting their fire inspection, once this is completed the facility will meet requirements under the Act and regulations and will be recommended for licensing.
