Comments: Medications were all in their original containers with children's names on them, some were missing the dosage. Dosage must be added.

Comments: Some bottles did not have covers, all bottles must be covered.

Comments: Some bottles were not labelled with child's name, all bottles must be labelled.

Discussion with operator and director regarding outdoor swing in infant area and outdoor lookout structure in preschool play area. Advised that they read the instructions manual to ensure they meet installation requirements. Also recommended that sand be raked under the lookout structure.
