Non prescribed medication is now labelled with the child's name and dosage, a supporting photo was sent to the quality insurance monitor.

Observations: Children were waking up from their nap, they ate their snack and got ready to go outside.

Facility is awaiting their fire inspection, once this is completed the facility will meet requirements under the Act and regulations and will be recommended for licensing.
